– hereinafter collectively as: Parties – on the date and at the place indicated below and subject to the following terms and conditions:

1./ The Parties stipulate that Principal, as a contributing entity, collaborates at the series of events titled “BrainBar Festival” held by Brain Bar Korlátolt Felelősségű Társaság (H-1122 Budapest, Székács utca 29.) between 21.09.2023. – 22.09.2023 (hereinafter as “Events”).

2./ The Principal assigns the Assignee to perform the following tasks at the Events to ensure its successful performance:

- Escorting guests in the premises of the Events
- Handling tickets
- Coordinating visitors

3./ The Parties stipulate that Assignee undertakes to perform the tasks indicated herein for the Principal **at no charge**. The Assignee accepts the assignment.

4./ The Parties stipulate that the place of performance of the tasks shall be Budapest, House of Music, Hungary

5./ The Principal shall provide the information necessary for the performance of the assignment to the Assignee. The Parties agree that the Assignee may accept instructions related to the performance of the event directly from the organizer of the Events.

6./ The Assignee shall act personally when performing the tasks specified in clause 1, due to the nature of the assignment.

7./ The Assignee may not disclose information related to the Principal's operations to any third party or entity without the prior written consent of the Principal. Such information shall include, in particular, information related to the Principal's operations and business policies. The Assignee shall be bound by the aforementioned obligation even after the termination of this contractual relationship, **which will be in effect indefinitely**. The Assignee acknowledges the rules relating to confidentiality and undertakes to comply with such rules. The Assignee acknowledges that, in the event that they cause any damage to the Principal by way of a breach of confidentiality obligations, **they shall have civil and criminal liability for the breach of confidentiality and for damages**.

8./ The Assignee declares that they consent to the processing of their personal data by the Principal and also authorises the Principal to provide their name and telephone number to Brain Bar Korlátolt Felelősségű Társaság (registered address: H-1122 Budapest, Székács utca 29.) to ensure more efficient organization.

9./ This Contract may terminate:

- by the mutual agreement of the Parties;
- by termination with cause.

10./ The Parties shall have the right to terminate this Contract by mutual agreement in writing at any time.

11./ The Parties shall have the right to terminate this Contract with cause with immediate effect if the other Party is in a material breach of their obligations set forth herein.

12./ This Contract shall take effect when signed by both Parties and the Parties enter this Contract for the period specified in clause 1. The Parties stipulate that this legal relationship does not qualify as public interest voluntary activity under Act LXXXVIII of 2005.

13./ Issues not regulated herein shall be governed by the laws of Hungary.

14./ The Contracting Parties declare that they have read and interpreted this Contract which they confirm by their signature.

15./ This contract is prepared in Hungarian and English, in the case of disputes, the Hungarian version shall prevail.
